- Stirling Knights reserve the right to revoke a players membership of the club should they not follow the code of conduct outlined. 'please note : Any concerns or complaints can be raised with parental reps who will report to the CPO who will report to the Chair and Management Committee who in turn will consider the complaint / concern and decide on future action in consultation with Basketball Scotland'. - Release: Please be aware that if for any reason a player wishes to join another club before their 18<sup>th</sup> Birthday that a development fee of £50 per every season registered with our club shall become due and payable to **BasketballScotland** by the Player or Parents/Guardian or receiving club thereof. This fee will be passed to the releasing Club as per clause 3.3.6 of Basketball Scotland Regulations and Code of Conduct.
